The tenders shall be submitted to the Construction Engineer, KLDC, Thrissur as specified in the Bid Documents. The bidder shall download and fill up pre-qualification sheet, technical bid sheet, price bid sheet in prefixed formats. The filled-up sheets along with the signed preliminary agreement in the prescribed Kerala Stamp Paper (Rs. 200/-) duly signed shall be uploaded in the website along with NIT Vol I and II. Additional documents are to be scanned and uploaded in the website. The bidders shall submit the pre- qualification sheet, technical bid sheet, the original / attested copy of the all the scanned documents including the signed preliminary agreement before the opening of the tender as specified above. The price bids are to be submitted only electronically.

In the event of discrepancy between the scanned copy and the original submitted or if the bidders fail to submit the documents within the prescribed time, the tender submitted by the bidders will be summarily rejected and the EMD forfeited.

For uploading the price bids, the bidders has to remit the amount towards cost of tender documents as well as the prescribed EMD through online payment gateway. Once the payment transaction is successful, the bidder will get a transaction reference number which has to be retained by him. Unless the tender cost and EMD payments are made successful, the submission of the tender will not be possible.

KLDC is not responsible for any problem in the site for payment / uploading during closing hours of tenders. Hence the Contractors are advised to upload the tender at the earliest. KLDC will not be responsible for any costs or expenses incurred by the bidders in connection with the preparation or delivery of the bids.

Technical Bid shall be opened as specified above. The Bidder or their authorized representatives are advised to attend the specified tender opening.

The price bid of the contractors whose technical bids are at par with the NIT and who have satisfied the necessary pre qualification criteria only will be opened by the Construction Engineer, KLDC after giving due information about the date and time to all the prequalified bidders in advance. The Bidder or their authorized representatives are advised to attend the specified tender opening online/ offline.

The Pre-qualification criteria are described in the Bid documents. The Construction Engineer, KLDC reserves the right to recall the invitation of bid/reject the application for Bid documents/extend the date of any notified date regarding this bid without assigning any reason.

The decision of the Construction Engineer/Technical Committee/Authority regarding the eligibility to be selected for the opening of the financial bids will be final. The bidders are advised to be present for the opening of tender.
