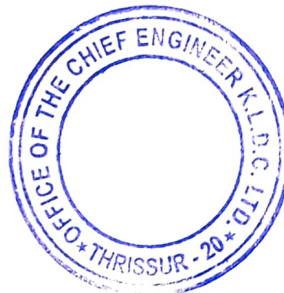

1 Introduction

1.1 About Kerala Land Development Corporation Ltd.

The Kerala Land Development Corporation (KLDC) Ltd was incorporated in 1972 as a fully owned Kerala Government Undertaking under the administrative control of the Agriculture Department with a view to promote, undertake and execute land development and allied schemes in Kerala for the integral development of Agriculture, with the objectives of develop quality structure and related infrastructure facility for the agriculture community in the state at reasonable cost.

1.2 About the Outlines of Project

The objective of this assignment is to ensure that the works executed conform to prescribed technical standards, specifications, and approved drawings, and to provide recommendations for improving the quality assurance and control mechanisms.

The Kerala Land Development Corporation Ltd. (KLDC) invites Expression of Interest from qualified and technically competent LBS Centre for Science and Technology and Government Engineering Colleges to carry out the Quality control Assessment of Projects sanctioned under RIDF .

1.3 Scope of Work and Procedures Adopted

The scope of work for assessment of quality of civil engineering works executed by the Department shall broadly include the following activities. The agency shall carry out the assignments in accordance with the directions and guidance issued by KLDC, ensuring objectivity, technical integrity, and adherence to relevant codes and standards.

(1) Conducting Periodic Inspections during the Course of Work

- The agency shall conduct a **minimum of three (3) inspections** at different stages of execution — such as at the initial, intermediate, and final phases — to monitor quality and workmanship.

- Additional inspections shall be carried out as deemed necessary depending on the complexity, progress, or criticality of the work.
 - Each inspection shall focus on verifying compliance with approved drawings, material specifications, and standard construction practices.
 - Detailed inspection reports, along with photographic documentation and remarks, shall be submitted after every visit.

(2) Verification of Test Results Submitted by KLDC Engineers

- All **test results and quality control reports** generated by the Engineers of KLDC or their authorized laboratories shall be examined and verified by the agency.
 - This verification shall include reviewing test procedures, sampling methods, frequency of testing, and conformity of results with relevant IS codes, MoRTH, and departmental specifications. Where necessary, the agency may recommend additional or confirmatory tests to validate the quality of materials or workmanship.

(3) Providing Suggestions for Rectifications During Inspections

- During site inspections, if any **defects, deficiencies, or non-conformities** are noticed, the agency shall promptly provide **practical and technically sound suggestions** for rectification. Such recommendations shall be communicated in writing to the concerned field officers, specifying the nature of deviation, its likely impact, and the corrective measures to be undertaken to restore compliance with standards.

(4) Issuing Technical Suggestions and Recommendations

- The agency shall extend **technical guidance and advisory support** to the executing team during the course of construction. This includes providing timely recommendations for resolving **technical or procedural problems** that arise during execution, such as issues related to materials, design implementation, drainage, compaction, structural detailing, or construction methodology.
 - All such suggestions shall aim to enhance durability, safety, and cost-effectiveness of the work.

(5) Appraisal by Visual Rating

- A **visual appraisal and qualitative rating** shall be conducted for each work inspected, based on observable parameters such as surface finish, alignment, uniformity, workmanship, adherence to design intent, and general quality appearance.
- A **numerical or categorical rating system** (e.g., Excellent / Good / Satisfactory / Poor) shall be adopted to standardize the evaluation.
- The final visual rating shall form part of the consolidated quality assessment report, along with justifications and photographic evidence

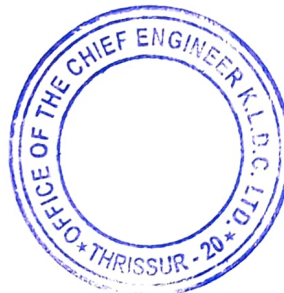
